Mr. Perrotta is currently the Founder and CEO of ResurgeTech Advisors, a Singapore-based advisory firm he established in December 2023. Having stepped away from day-to-day CEO responsibilities, I now focus my energy on advising company boards and private equity firms.

Before Interplex, Mr. Perrotta served as CEO at FCI Electronics from 2013 to 2016. FCI Electronics's focus was on the high speed and power interconnect servicing the Datacom/Telecom and Industrial market.

Prior to FCI, Mr. Perrotta also served in several leadership roles in the area of Renewable Energy at REC Solar ASA, a Norwegian company focusing on Wafer, Cell, Modules design and manufacturing as well as Solar System Infrastructure. The main manufacturing location was and still is in Singapore.

Mr. Perrotta specializes in supporting Private Equity companies in transformation, due diligence and other aspects of strategy and technology.

Mr. Perrotta is also serving as a Vice President for the Singapore Manufacturing Federation (SMF). Mr. Perrotta is also Chairman of the Global Business and Membership Function Committee within SMF.

In 2019, Mr. Perrotta was named Honorary Ambassador to Singapore for The Confederation of Industrial Chambers of Mexico (CONCAMIN). CONCAMIN was constituted in 1918 and is the representative organism of the different industrial sectors and other important economic activities for the economic development of Mexico.
